Completed Last Quarter

- The project implementation was approved on June 27. The project impact evaluation was approved on August 5.
- The Director General for Teachers and Education Personnel (DGTEP) of the Ministry of Education and Culture (MoEC) issued the decree for the KIAT Guru National Coordination Team on July 25.
- Grant Agreement between the World Bank and Yayasan BaKTI as the implementing agency for KIAT Guru became effective on August 9.
- Five districts agreed to participate in the pilot: Ketapang, Landak, and Sintang in West Kalimantan; and Manggarai Barat and Manggarai Timur in East Nusa Tenggara. Selection of 270 participating schools (inclusive of control schools) finalized.
- Completed recruitment of field implementation teams.

Upcoming This Quarter

- Baseline survey and qualitative research phase 1 implementation.
- Training and deployment of field implementation teams to start implementation in five districts.
- MoU signing between MoEC, TNP2K, and the Bupati of five pilot districts.
- DGTEP Technical Guideline for KIAT Guru.
- Bupati decrees will be established for KIAT Guru District Coordination Teams in five districts.
- Socialization of activities at the district, sub-district, and village levels.

MoEC new regulation on *Tunjangan Khusus*, increased the technical complexity and geographical span of the project.

MoEC is undergoing budget cuts as a result of the Government of Indonesia's fiscal constraints. This may impact the amount of budget allocation for the project.

Mitigation

The Task Team and BaKTI will work very closely with MoEC and monitor actual implications.

MoEC will recalculate and decide on the budget for KIAT Guru, the Task Team will recalculate the remaining budget needed.
